Sunnyslope County Water District Summary of Rates & Fees

Sunnyslope County Water District is committed to providing the best quality service for the least possible cost. The District's rate structure is designed to be sufficient to cover the cost of operations, maintenance, administration, emergency reserves, and capital improvement projects for the water and wastewater systems. As a public agency, the District does not make any profit.

Water Rates, Effective August 1, 2024, by Ordinance No. 82 approved Aug. 6, 2024

The District assesses a monthly service charge based on water meter size, plus a monthly consumption rate based on the amount of water consumed. Consumption is billed in full units of hundred cubic feet (HCF) where one HCF equals about 750 gallons. The monthly consumption rates for single-family residential customers use a progressive rate format in which the cost per HCF increases as more water is consumed. Non-single-family rate has no tiers, so customers are charged one rate per HCF regardless of consumption. Fire Service Charge is based on service size applies only to dedicated fire services, usually only for commercial or institutional customers.

Sewer Rates, Effective Beginning December 21, 2014:

The District currently charges residential sewer customers a monthly service charge plus a monthly volume charge based on the average amount of water consumed** for household purposes. Non-residential sewer customers are assessed a volume charge based on metered water usage. The sewer rates were approved by the Board of Directors on August 6, 2013, by Ordinance No. 74 and current rates took effect on December 21, 2014. The sewer rates were amended to put a cap on average winter water use in drought years by Ordinance No. 71, which took effect May 3, 2012.

Capacity Charges, Effective Beginning July 1, 2024

The water and sewer capacity charges (connection fees) were approved by the Board of Directors on August 6, 2013, by Ordinance No. 75. The current charges became effective July 1, 2024. The capacity charges are adjusted annually by reference to the Engineering News Record (ENR) index in accordance with District Code Section 3.40.030 and Section 4.30.020.

^{**} The consumption charge of \$5.64 per HCF for single- and multi-family dwellings is charged based on the average winter water usage for February and March and is updated each April. In drought years, as determined by the Board of Directors, customers whose average winter water usage increased by 4 or more HCF for February and March over the prior year, will have their increase capped at the prior year average plus 4 HCF.
